- Saw our 4th consecutive year of growth with over 129,000 visits to the visitmercercountypa.com website. This was an increase of 11.9% year over year.



# Program Results

# **GOLF**

This year we attended the Toronto, Cleveland and Pittsburgh Golf Shows promoting Stay & Play Golf packages, our membership courses, and things to do while in Mercer County. This fiscal year we received 48 golf package requests through our online request form. Those 48 golf groups represented 389 golfers.

## **GROUP TOUR REPORT**

# **HOTEL EXCISE TAX**

Mercer County is set to experience continued growth in the travel and tourism sector through the remainder of 2025 and into 2026. The development of a new extended stay hotel in West Middlesex will further expand accommodation options for visitors. Additionally, two Mercer County hotels have undergone complete renovations in recent years, while others continue to implement upgrades that enhance the overall guest experience. These improvements encourage increased stays for weddings, bus groups, college and youth sport teams, and group corporate stays.

A significant infrastructure initiative began in April 2025—the \$115.7 million reconstruction of the first five miles of Interstate 80 in Mercer County. This project aims to improve both eastbound and westbound traffic flow, reinforcing I-80's role as a key gateway into Pennsylvania. These enhancements are expected to improve accessibility and attract increased visitor traffic to the region.

With ongoing reinvestment in hospitality, a substantial commitment to transportation improvements, and VisitMercerCountyPA's ongoing efforts to promote member attractions and support tourism through grant and marketing programs, Mercer County is well-positioned for sustained growth in its tourism industry.

The room tax revenue increased 7.36% from fiscal year 2023/24.

Moving into the new fiscal year, we are prioritizing TikTok as a key growth platform, focusing on strategic efforts to expand our audience after previous uncertainty about its longevity.

# LAKE TO LAKE PADDLE CHALLENGE

The fourth annual Lake to Lake Paddle Challenge returns on August 23rd, 2025. The event features a 30-mile kayaking and canoeing competition from Pymatuning Lake to North Star Marina at Shenango Lake, and a 15-mile adventure race from Kidd's Mill Covered Bridge to North Star Marina. This event promotes outdoor recreational opportunities on the waterways in Mercer County which include the dam outflow at Pymatuning State Park, Shenango River Water Trail, and the Shenango River Lake. These waters are the perfect natural setting for wildlife watching, fishing, boating, sailing, kayaking, canoeing, stand-up paddleboarding, tubing, skiing, sunbathing and more.

# Strengthening & Expanding Tourism in Mercer County

# **COOPERATIVE ADVERTISING**

In County members can participate in cooperative advertising which helps stretch their marketing dollars. Up to \$20,000.00 is available for each partnership. VisitMercerCountyPA provides a dollar-for-dollar match on advertising to promote overnight stays and a 50% match on advertising that promotes day trips. Two or more partners must work together and apply to access this program.

## TOURISM ATTRACTION DEVELOPMENT GRANT

This grant provides funds for new developments, expansions, renovations, and improvements of tourism attractions in Mercer County, PA. The maximum amount available is determined each fiscal year and must be leveraged with at least 50% of eligible project expenditures from other sources.


# FESTIVALS, FAIRS AND LARGE EVENT MARKETING GRANT

We provide direct marketing grants to non-profits and community-based organizations hosting festivals, fairs and large events to assist them in promoting their event. The amount available per event is determined each fiscal year and must be leveraged with a 25% match.

## LOCAL BILLBOARD PROGRAM

The agency pays ½ of the cost of local billboards up to \$1,000.00. The billboard can be stationary or mobile (company vehicle wrap). A requirement to access the program, the VisitMercerCountyPA logo must be shown prominently on the billboard.





# **BEAUTIFICATION PROGRAM**

The Beautification Grant seeks to help downtowns/city centers, main travel corridors, and public areas create what we call a "wow" experience for visitors and residents. \$100,000.00 has been earmarked to help in this effort. A 25% match is required with up to \$20,000.00 available per approved project.

## TOURISM CASH GIVEAWAY

Over the St. Patrick's Day weekend, we conducted our 9th Annual Mercer County Tourism Cash Giveaway. For this promotion, through our Facebook page, we gave away \$100 in Tourism Cash to the first 200 Facebook followers who clicked on a link in a post and signed up to be a winner. Within 1 hour and 58 minutes we received 200 entries. Out of the 200 winners, 190 people came to our office to pick up their Tourism Cash. The excitement from our participating members and contest winners was amazing.
